Public awareness and education consists of the costs associated with attending conferences, seminars, and trade shows for the purpose of teaching, informing and causing awareness of the serious situations that exist in the world regarding human trafficking and sex slavery of children.

Cost of jewelry and apparel consists primarily of items created by girls who have been rescued from sex slavery. These items are for resale, the proceeds from which support the ongoing care, counseling, and nurturing of these children.
