RESCUE KIDS AND KEEP THEM FREE:

In 2021, Destiny Rescue agents and partner organizations rescued 2,386 victims across nine countries, 70% being children - an average of six rescues per day! Of these survivors, 1,212 entered our reintegration programming and received individualized Freedom Plans, including things like housing, health needs, economic assistance, counseling and education. As of December 2021, for all-time totals, we rescued over 8,000 individuals, arrested 419 trafficking perpetrators in collaboration with law enforcement and shut down 20 sex establishments.

EMPOWER PEOPLE TO RESCUE KIDS:

Destiny Rescue seeks to inspire and equip organizations, churches and individuals to rescue kids and keep them free. In addition, we aim to educate on human trafficking for individual and communal awareness and safety. Programs include: RescueOp1/20 - educating students and empowering them to combat the crisis of child sex trafficking, Advocacy - volunteers using their gifts and talents to raise funds and awareness, Rescue Sunday - equipping churches to educate on human trafficking and help rescue kids, and Artist Speaker Program - utilizing the voices of well-know public figures to spread awareness and inspire rescue.

Sponsorships consist of the costs associated with promoting and securing support from donors for children within Destiny Rescue and partner organization's care.
